PAC Meeting – March 3, 2021

Principal update;

COVID Exposures to date (as of March 3)

- 2 classes in isolation (one ending Mar 9 and one ending March 12)
- 1 class to self-monitor with an additional 9 individuals asked to self-isolate, ending March 9.
- 1 class asked to self-monitor due to an exposure on Feb. 24

When we get a parent disclosing – procedure is;

- admin calls to get more information from the parent and we fill out the district H&S form
- This form goes to the COVID communication department at the district. This team is in communication with the school hub of FH daily
- If in the individual contact tracing, FH deems the school needs to be issued an exposure, they send the letter to the COVID communication and this then goes out to the parent community.

Why is there a delay for the school communication?

FH is responsible for contacting the individual who has tested positive, they need to
then reach out to that individual twice and allow 24 hours for the positive case to
contact them. School and district has to wait until this contact tracing to be completed
to figure out if the school community gets an exposure letter.

When a class is put in isolation, what happens?

- Admin contacts the families directly to explain the process and exposure date
- Once calls are made, the letters go out to the individuals impacted and then out to the general school community as notification
- Students will be issued curriculum within 1-2 days of isolation so that they can continue their learning remotely
